2. Conditional bids shall not be accepted. The EMD of unsuccessful bidders will be refunded after finalization of the tender, while that of the successful bidder will be refunded after submission of the required Performance Security.
3. Prime Manufacturers must submit a self-declaration on their official letterhead confirming that they are regular manufacturers of the quoted Interactive Pannels and Computers.
4. Authorized Distributors/Dealers/Agents must upload valid authorization letters from the Original Equipment Manufacturer (OEM) along with the bid.
5. The bidder must be in operation for at least **Two (02) years** in the field of supply, installation, and maintenance of Interactive Pannels and Computers.
6. The bidder must demonstrate the capability to provide timely service support. Any system complaint must be attended within **03 days**, and fully resolved within **10 working days**.
7. Audited Financial Statements for the last **two (02) financial years**, duly certified by a Chartered Accountant, must be submitted.
